



STUDIO POLICY

Lesson Schedule for August 2025 through May 2026

- ***SCHOOL-YEAR LESSONS begin August 4, 2025 to May 29, 2026***
 - **No lessons on the following dates:**
 - 9/1: Labor Day
 - 11/24 – 11/28: Thanksgiving Break
 - 12/20 - 1/4/26: Christmas Break
 - 5/25/26: Memorial Day
 - **Summer schedule starts June 1, 2026 to July 31, 2026.**

Tuition & cancellation policy:

Your tuition pays for your reserved time in the studio schedule throughout the year. **If you must miss a lesson, please provide a 48hour notice prior to your lesson schedule (apart from an emergency situation). If you contact us 48hours prior, we will put you on a swap list.** If the teacher must miss a lesson, we will do the same and notify you 48 hours in advance, except for emergency situations, we will work with you to reschedule that lesson at your convenience. **For group lesson: we do not offer make up or swap list if you miss a class.**

Monthly tuition is a flat rate of \$140, regardless of whether the month has 3, 4, or 5 weeks. Our tuition is structured this way to keep billing simple and consistent throughout the year. Some months may have fewer lessons and others may have more, but it balances out over time.

Payment is due every first lesson. Failure to pay on time for lessons results in one warning and a **\$10 late fee fine**; further lessons are canceled if payment is not received in 2 weeks.

Student Drop-off

- Students arriving late will not have their lesson time extended. Teachers will only wait until 15 minutes and will forfeit the class period.
- If you need to speak to the teacher, please do so during your student's lesson time or arrange for a meeting/phone call later. Keeping these conversations within the designated lesson time avoids interfering with another student's lesson time.
- For safety reason please make sure you drop off your child inside the music hub and pick them up at the end of the class.

Student Illness: No student should attend lessons when sick (i.e. fever, nausea, vomiting, etc.) I reserve the right to dismiss a student from a scheduled lesson if the student arrives at that lesson exhibiting possible symptoms of illness.

Practice Time: *Daily* practice is *required* for lessons to be effective. Teachers will work with each student to determine the amount of time appropriate for level and age. **Please download the PRACTICE SPACE APP and enter studio code: QWWYKS**

Discontinuation of Lessons: We understand that, for different reasons, a student may wish to discontinue lessons with us. Please give at least two weeks advance notice of your decision. No refunds will be given for discontinuing lessons before the end of your prepaid lessons. You may give notice via email at doremimusicclub@gmail.com or by phone 559-670-4086.

Dismissals: We have the right to dismiss a student if any of the following circumstances occur:

- *Failure to pay tuition on time
- *Persistent absences
- *Uncooperative attitude (blatant disrespect, bad language, or inappropriate/inexcusable misbehavior).
- *Lack of progress due to insufficient practice.
